The grantee will continue providing information and training activities at the European Interactive Center, which was established in 2006 in Balti city. Targeting students, youth, women, teachers, local government officials, business groups, and other interested groups, the center will continue to act as a platform for information and discussion on issues related to European integration. As a result of the project, the public will be more informed and more engaged in EU-related issues such as EU affairs, work and education in EU countries, and EU regulations affecting Moldova. The funding for this initiative is provided by Sweden and Ministry of Foreign Affairs of Denmark.

The project will provide assistance to the Central Electoral Commission in ensuring the accessibility of voting for persons with disabilities by testing new voting methods for persons with visual impairments, by printing the voter's guidebook in Braille, by developing and posting information on inclusive voting. The action will sensitize political parties and media on the issues faced by the persons with disabilities and mobilize them to act in order to address them. In addition, the grantee will involve the general public in monitoring the accessibility of polling stations through the Ushahidibased online platform. The funding for this initiative is provided by Sweden.

## 14. AO "Asociația Presei Independente"

Thus, by current project proposal 20 people will benefit on a three months course on performing massage services. Further on 3 beneficiaries will be employed within Center for Manual Therapy that is to be created as an additional project output. Other 10 beneficiaries will be supported in order to perform similar services at home or within their village/town. According to enterprise's business plan, investment redemption will take 2,5 years and yearly net profit is expected to be up to 30 thousands lei. It will be used to multiply the number of beneficiaries of this social initiative. The funding for this initiative is provided by Sweden.

## 44. AO Clubul Femeilor "Inspirație"

"Development through harnessing local entrepreneurial potential" is a project, which will establish healthy public alimentation services for pupils from Oxentea village, including vulnerable youth through a social enterprise. Thus, 20 pupils will benefit on free lunches offered by the enterprise, the rest of the pupils will have access to healthy food at a low price. At the same time, the enterprise will perform catering services on a commercial base. The profit generated by the economic activity will be redirected to support the social activities of the organization. The funding for this initiative is provided by Sweden.

#### 45. AO Asociația de sprijin a copiilor și tinerilor cu dizabilități "Dorința"

Grant amount: **27,200.00 USD**Grant period: 28/02/2014 – 31/12/2016

The project to be implemented by "Dorinta" NGO will contribute to increase the quality of life for children and youth from Calarasi district of Moldova through improving the sustainability of day-care Center managed by the association. Thus the grantee will offer on commercial basis services for renting a room for ceremonies, fitness room and health massage. The money to be cashed upon these services will be used according to Association's statutory provisions and will contribute to financial diversification and sustainability of the organization. Social enterprise "Mara" aims to offer employment opportunities for disadvantaged women from rural areas (human traffic victims, single mothers, uneducated women etc.) by manufacturing articles of knitwear. Project beneficiaries will be trained and employed, thus improving employment situation within women. All the products will be sold through international e-commerce platform <a href="http://marawoman.org/">http://marawoman.org/</a> which is oriented on EU, USA and Canada markets. Social impact of the project will be reflected by the alternative that it will offer to women to stay home beside their families and at the same time contributing to communities' development; reducing the risk of children growing without their mothers; women emancipation by actively involving them economic and social community life and rising women role in rural communities. The profit generated by the enterprise will be redirected to women salaries and also for different local social initiatives. The funding for this initiative is provided by Sweden.

## 48. AO "Motivație"

Grant amount: **29,743.00 USD**Grant period: 28/02/2014 – 31/12/2016

The "Social entrepreneurship for people with disabilities" project targets to include people with disabilities within labor market. Association "Motivatie" will create employment opportunities for 2 people initially; further on the number of employers will increase up to 4. At the same time, the project will contribute at increasing the level of financial sustainability of the organization. The economic activity of the project consists in installing auto simulation machines within shopping centers from Chisinau. Further on the organization plans to extend this business to a driving school for people with disabilities. The funding for this initiative is provided by Sweden.

## 49. AO "Eco-Răzeni"

Grant period: 28/02/2014 - 31/12/2016

Through current project proposal the "Eco-Razeni" NGO will social integrate 10 youth with disabilities from Razeni village, Ialoveni district by employing them within social enterprise "Floare de cires" and develop their life skills. Thus, till the end of the project this youth will become from social services beneficiaries in tax payers. At the same time, during the project will be organized a raising awareness campaign to promote social entrepreneurship and continuously performing social catering services. The project "Growing vegetable in greenhouse with advanced technologies for saving energy resources" will create 3 new working places and also will maintain other 2 within social enterprise "ArtDedal" managed by Youth Resource Center "Dacia". This project implementation will ensure sustainability of youth placement services provided by the Center through growing vegetables for Center's beneficiaries and through generation of about 24,000 lei yearly for supporting organization's operational costs. At the same time it will create a new greenhouse model with a new approach for using energy resources, thus reducing production costs and decreasing the price of vegetables according to market demand. As a result, the data collected will be compiled into a single document - Inclusive Development Chess Strategy developed in partnership with the Ministry of Youth and Sports of the Republic of Moldova. The Strategy is going to be

submitted to the Government of the Republic of Moldova, the final version will be published in 1000 copies and will be disseminated throughout the country, in the educational institutions, libraries, NGOs, chess players, sports clubs etc. As a result of the project the public will become more informed and responsive to the problems of the disadvantaged people, the strategy will be accessible and will serve as the basic document of the inclusive chess development and the inclusive practice development strategies will become a well known practice used in Moldova.
