COMPONENT 1.1: Civil society participation and oversight

1. IDIS Viitorul

Grant amount: 20,003.00 USD

Period of implementation: 01/08/2017 - 31/01/2018

The project proposal "Preventing pitfalls in implementing Moldova's European obligations: policy advocacy and public awareness" is to prevent and conciliate various gaps existing between the Moldovan Government commitments under the EU-Moldova Association Agreement (including the DCFTA) and policy priorities in 2017, while endorsing targeted reforms and policy dialogue between stakeholders. The funding for this initiative is provided by Sweden.

2. AO "Synergetica Eur-Est"

Grant amount: 21,370.00 USD

Period of implementation: 15/06/2017 - 31/10/2017

The project aims to boost the development of the civil society, by engaging the representatives of this sector in a discussion platform – Civic Fest, which supports social entrepreneurship, social responsibility and civic volunteerism. Through this initiative, best European practices will be promoted and shared within a 3 days' event (of two days in Bucharest on 17-18 of June and one day in lasi on 24 of June within NGO Fest Romania) with participation of Moldovan and European NGO representatives, businesses and international community. This way, civil society actors will become more active in the field, by developing and implementing new initiatives based on the experiences shared during the event. The project will foster the development of a multicultural and multidimensional communication platform for the actors of Moldovan civil society and their European counterparts. COMPONENT 1.2: Encouraging active citizenship and critical thinking

3. AO "URMA TA"

Grant amount: 9,918.00 USD

Period of implementation: 15/02/2017 - 31/03/2018

The project is designed to increase the access of media consumers to information about local initiatives that have a positive impact on communities. The grantee will achieve the following outputs: build the capacity of journalists of the www.stiripozitive.eu news portal to reflect information of public interest; increase the information flow about local initiative and success stories at the local level; promote positive initiatives and good practices among local administrations, businesses and viewers. In the long run, the project will strive to provide media consumers with unbiased information, which is relevant for various groups and communities. The funding for this initiative is provided by Sweden.

4. AO "Asociația Presei Independente"

Grant amount: 15,988.00 USD

Period of implementation: 03/04/2017 - 31/12/2018

The goal of the project is to strengthen the quality of journalism and to promote the journalistic good practices in Moldova through ensuring the functioning of the Press Council as a self-regulatory mechanism that settles amicably conflicts arising between readers and the media. To reach this goal, the Press Council will seek to have the conflicts solved by using media regulation tools. Also the Press Council will promote good practices in the media deontology through a round table for journalists and opinion leaders and through consolidating external communication with similar structures from other countries by participating at two annual international conferences of the Alliance of Independent Press Councils from Europe (AIPCE) and at the meeting of the media self regulating network from the former soviet countries. The funding for this initiative is provided by Sweden.

5. AO "Centrul Pro-Europa din Comrat"

Period of implementation: 15/02/2017 - 30/09/2017

The goal of the project is to contribute to capacity and potential development of youth for a better life and social welfare in Gagauzia and Taraclia Rayon, as well as to develop positive perception of the reforms within the Association Agreement between EU, European Society on nuclear energy and Republic of Moldova. The funding for this initiative is provided by Sweden.

6. AO "Juriștii pentru Drepturile Omului"

Grant amount: 8,688.00 USD

Period of implementation: 14/04/2017 - 13/10/2017

The project seeks to consolidate the institutional capacity of the Civic Association Lawyers for Human Rights and to contribute to the legal empowerment of the population, especially in the area of access to information and proceedings of the European Court of Human Rights, with due attention to underrepresented and vulnerable groups and journalists. The project will support the grantee, the organization that instrumented one third of successful cases at the European Court of Human Rights, to become more efficient and strategic. Due to a distinct visual identity, the organization will provide increased access to information on the ECHR case-law and strategic litigation. The project will also contribute to increased communication with the media in order to streamline in the agenda of the media the subjects related to human rights and public interest information, including information on the integrity and professional record of the magistrates and prosecutors. The funding for this initiative is provided by Sweden.

COMPONENT 1.3: Free, fair and inclusive elections

7. Centrul Parteneriat pentru Dezvoltare

Grant Amount: 24,290.00 USD

Period of implementation: 13/06/2017 - 31/12/2017

The project "National Mentorship for active women "INSPIR-O!" in localities with zero representation of women in local councils" seeks to enhance the leadership skills of groups of women in localities with zero representation in local councils. It will strengthen their potential to promote the concept of gender equality in local policies and to succeed in local political functions. This desideratum will be realized by identifying and actively engaging at last 23 women from targeted localities in a comprehensive mentorship program comprising the following components: (I) Training—women's leadership, good governance, community mobilization, project writing, risk management etc., (II) mentoring relation—the program will select as mentors persons with outstanding experience, resource persons for community groups, (III) small grants program, (IV) exchange of experience and

good practices with women from the previous mentorship programs. The funding for this project is provided by UN Women and Sweden.

8. AO "Gender Centru" Grant amount: 25,896.00 USD

Period of implementation: 02/01/2017 - 30/09/2017

The project proposal "Promoting Gender Equality in Moldova" is to upscale civil society mobilization, within the Gender Equality Platform, to exercise public pressure on political leaders and MPs for adopting placement requirements to the 40% gender quota. The grantee will host the secretariat of the gender equality platform and will ensure proper coordination and communication within the network. In collaboration with other NGOs, the grantee will carry out innovative public actions to promote women in politics, meeting the decision-makers and other stakeholders, and awareness raising for promoting gender equality in politics. The activities of the seven regional women's political clubs will include but will not be limited to (i) coalescing women from various political parties around local development issues, (ii) identifying and empowering prospective women candidates to run during local elections, (iii) facilitating the dialogue between prospective women candidates and political parties, (iv) mainstreaming gender equality in the activities of the local public authorities, (v) supporting disadvantaged women from rural areas to articulate their issues and demand accountability from local authorities, (vi) identifying and engaging male champions for gender equality.
